Public Hearing Water Rates
Regular meeting
Junius Town Board
Junius Town Hall

Attendance: Supervisor Brownell, Councilmen Kyle Black, Thomas Davis, James Patsos and Richard Wadhams. Guest Pat Nicoletta.

Open: The public hearing was opened for discussion after Supervisor Brownell led with the pledge of allegiance at 7:00pm. Councilman Wadhams made the motion to open the hearing and Councilman Pastos making the second the hearing proceeded. Water rates are going up 14% starting September. No one wanted to address the board. Councilman Patsos made the motion to end the public hearing and with Councilman Wadhams making the second the meeting was adjourned at 7:02.

Regular meeting: The regular meeting opened at 7:02. First up was Pat Nicoletta spoke about a resolution to make a material payment to Geneva in the amount of \$1,897.12. Councilman Wadhams made the motion to pay and with Councilman Davis making the second the motion passed with all members in favor. At this time councilman Wadhams made the motion to support the Water Infrastructure Improvement Act, and with councilman Davis making the second the motion carried with all members in favor.

Town Clerk: Total disbursement of \$121.00 for the month showing the Town share as being \$102.00 was motion to accept by Councilman Pastos and seconded by Councilman Davis, which carried with all members in favor. Also at this time last month's minutes were motion to be accepted with one small correction by Councilman Wadhams and the second came from councilman Pastos. This motion carried as well with all members in favor.

Reports: Sewer was running well, business as usual.

Highway: Superintendent Fisk turned over \$295.70 in scrap metal from clean up days, to the Town Clerk. The department has been working on the waterline; they will be doing oil and stone beginning next week.

Building: Councilman Wadhams made the motion to have the building chair price out some doors for the main entrance into the building. Councilman Pastos made the second, which carried with all members in favor.

Planning board: They have been tweaking the sign ordinance for the Town.

Assessor: Final roll will be filed July 1st, 2018. Also the assessor is requesting additional money be put in next year's budget to do a property re-valve as it does take additional help to do so.

Bills: Pre-pays: General fund \$2,261.71, Highway \$1,966.39, Sewer\$228.77, Water District 1 \$120.12. Paid at the meeting was General fund \$49,703.82, Highway \$13,370.75, Sewer \$5,795.50, Water District 1 \$27,859.09 and Water District 2 \$1,847.47. Councilman Pastos made the motion to pay all bills and with Councilman Davis making the second, the motion carried with all members in favor.

Adjournment: Councilman Pastos made the motion to adjourn and with Councilman Davis making the second, the meeting was adjourned at 8:20.
