Committee Reports:

Water Committee: Thomas Maslyn, A Sensus representative for New York State, gave a presentation on new water meters. His company works with neighboring towns. The board will review the information Mr. Maslyn provided and discuss their options.

Highway Committee: Matt Horn reported that he submitted 2 grants to New York State, The Avery Road for 1.3 million and the Reed road for \$7000,000. He is hoping to hear back about these grants late spring or early summer.

Superintendent Dave Fisk reported that the Towns Payloader is having issues with its transmission. The guys are looking into it. Hoping its nothing major. Also The Town of Phelps is selling their 2011 John Deer front sweeper for \$10,000 to \$15,000. Dave also looked into a new salt box pricing. He is unsure if the box will make it through next winter.

Building committee: Nothing to report

Planning Committee: Planning Board Linda Mott sent the telephone pole paperwork to the lawyer to review. The lawyer was not comfortable with a couple paragraphs. It was decided to allow Mobility to remove their pole.

He reported that he is working on monthly deeds, splits, bank codes; address changes and administering the STAR program. On December 9th, 2022 NYS passed a bill for volunteer firefighters and ambulance workers to receive a partial tax exemption on their primary residence. On December 8th, 2022, NYS passed a bill which requires municipalities to notify senior citizens of the tax exemption that they may be eligible for via a second notice.
