Committee Reports:

Water Committee: Supervisor Brownell and Engineer Jason McCormick drove around the whole town looking at where they want to put the new water district. Jason was unable to make tonight's meeting.

The Town of waterloo is raising its water rates. It has already gone up for 2023 - \$3.99 per 1,000 gallons of water. We are currently paying \$3.68 per 1,000 gallons. In 2024 the rate goes up \$4.65 per 1,000; In 2025 \$4.98 per 1,000; In 2026 \$5.09 per 1,000 gallons.

Councilman Rick Wadhams made the motion to raise the water rate to \$3.99 per 1,000 gallons as was stated in the Public Hearing on August 16th. Councilman Kyle black second the motion. The board will review the next 3 years of rates and decide on further action.

Highway Committee: Superintendent Fisk let the board know that he has received complaints over the year from residents on Mills Road near Route 318. (it is very wet area). Junius Highway department has paved, striped the road and put shoulders on that road. The waterline was put in by private contractors and the side of the roads are rough and uneven. The area where the new water lines were installed, has now settled, and is causing issues. The highway department will get soil to put over the lines and try to level it out.

The striping company has finally showed up and striped our roads. The Highway department is in the process of marking trees that need to be removed. They will remove the bad trees in the next 2 months. They will contract Cut Throat tree service to get the ones by the power lines. The Highway department has also been helping Phelps with their water lines.

Three signs have been stolen from the Town, shortly after the signs being installed. Police reports have been filed.

Building committee: Supervisor Brownell would like to get new doors for the Town Hall. He will work on quotes. A Bee exterminator was called to spray the building. There has been a huge increase in Bee activity inside the building. Supervisor Brownell asked if we should look into getting a Generator for the Town Hall. He will look into quotes.

Dog Control: The Towns dog kennel passed its yearly inspection
